Description: Orthopaedics Litigation Claims

Response

1. The number of litigation claims lodged with UHMBT in the last 10 years relating to the orthopaedics department. Can this information be provided by year. Can this also be provided so that settlements refer to which clinician was involved - I appreciate this can't be given so that it identifies the clinical but I anticipate it can it be provided so that each claim can be attributed to a certain clinician (eg X amount paid in X MONTH and X YEAR relating to claim regarding CLINICIAN A/B/C/D)

Please find below a report from the claims database, listing all the clinical claims for orthopaedics advised to the Trust between 1/1/2010 and 31/12/ 2020, which have been reported to NHS Resolution (NHSR). The numbers are as follows:

The above report also indicates the number of cases where damages have been paid. The other cases have either been closed without payment or are on-going.

With regard to the attribution of claims to clinicians, we do not hold the specific information you have requested. Although we now record the names of those involved in a claim, the name generally relates to the clinician from whom comments have been sought and this may be more than one clinician for a single claim. Sometimes the responsible clinician has since left the Trust, in which case the name may be that of the current or lead clinician. Also, the allegations may not relate to the named clinician's care but rather that of a junior doctor or nursing staff.
